

# **2018 State Legislative Priority Issues:**

### **Education**

- What we support We support equitable funding for public schools so that we eliminate the need for operational referendums to maintain student programs and adjustments to the circuit breaker tax that are public school sensitive.
- Why it's important Hamilton County attracts high-growth, high-performing businesses and a highly-educated workforce by offering families outstanding public education. Fueling this growth are the schools of Hamilton County. They are among the highest performing schools in the State of Indiana and it is imperative that we maintain this standard.

## • Key points:

- ILEARN The new test would be used for the first time in 2019, ISTEP still has one more year of life. The Indiana Department of Education will be tasked with developing the new test and finding a vendor. The as yet defined test will be called ILEARN "Indiana's Learning Evaluation Assessment Readiness Network."
- Funding Lawmakers passed a two year budget in April 2017 however the state has about 6,000 more students than lawmakers budgeted for, possible shortfall \$9.3 million.

## **Economic Development**

- What we support We support maintaining Indiana's attractive tax climate to increase economic growth and prosperity.
- Why it's important Companies chose to invest in Hamilton County because of the positive business climate and people relocate because of the quality of life and jobs. In order to continue this growth we must maintain progressive incentives that encourage new growth and redevelopment of existing resources. Indiana must also maintain their economic competitiveness through the retention and responsible use of existing tax credits.

#### Key points:

o **Software as a Service tax (SaaS tax)** – SaaS tax is applied where software is hosted in one place but licensed, by subscription, for use by customers in another state and taxed. The Governor will ask lawmakers to exempt cloud or subscription-based software—often called software as a service—from Indiana's 7 percent sales tax. The issue has popped up nationwide as current tax codes have clashed with the advent of cloud-based computing, which has changed the way products are sold and delivered. **OneZone Supports** this exemption

#### **Home Rule**

• What we support – We support Indiana's Home Rule Act first passed in 1980 that generally grants municipalities the power to govern themselves as they see fit. The idea, modeled off the national principle of federalism, gives more choice, options, flexibility and freedom to local leaders.

Why it's important – Mayors and City Councils are best suited to enact legislation that effect
our communities. We believe that greater home rule provides flexibility for our locallyelected officials, the state's "one size fits all" philosophy is not in the best interest of our
members.

## Healthcare

- What we support We support legislation or initiatives that improve healthcare affordability or provides incentives for individuals to be more health conscious. We also support initiatives that address mental health issues and opioid abuse.
- Why it's important Indiana is one of the unhealthiest states in the nation, ranking 41<sup>st</sup> for overall health of its citizens. Having healthy citizens is vital to the state's economy and to our quality of life. An unhealthy work force impacts Indiana's ability to attract quality businesses and increases healthcare costs.

## Key points:

- Smoking OneZone Supports legislation designed to discourage smoking.
- Opioid Abuse This has become a major issue in Indiana and We Support initiatives that address prevention and treatment in addition to strengthening enforcement efforts and penalties for those who illegally manufacture drugs that result in death.

## **Workforce Development**

- What we support We support legislation that encourages workforce initiatives in Indiana.
- Why it's important Hamilton County's unemployment rate hovers around 2% which is full employment. Because of our low unemployment rate the ability of business to attract talent is difficult and job openings exist in most employment sectors. Continued strong economic development requires an available and educated workforce.
- Key points:
  - Indiana spends roughly \$1 billion on different funding streams and programs for workforce development. OneZone supports a comprehensive examination aimed at a more effective result.

#### **Alcohol Code Revision**

- What we support We will be monitoring the Alcohol Code Revision Commission as they start on their two year process of examining Indiana's Alcohol Laws.
- Why it's important Indiana needs to evaluate current alcohol laws to eliminate conflicts
  that currently exist and to bring them up to date ensuring fairness to businesses that deal in
  beer, wine and alcohol.

#### **Autonomous Vehicles**

- What we support OneZone supports legislation that would authorize the testing and operation of autonomous vehicles on state roads.
- Why it's important Self-driving cars and trucks may be years from reality but it is important that Indiana needs to act now to try to ensure that we are a part of researching and developing the technology.

#### **Mass Transit**

- What we support We support placement of the referendum question on the ballot which could eventually fund the Red Line in Hamilton County. We will monitor any proposed changes to the current mass transit legislation.
- Why it's important Many Hamilton County employers struggle to find employees and a consistent obstacle is reliable mass transit. A mass transit system would help by providing transportation for out of county workers and would also allow our businesses to increase their competitiveness in the region.

## **Regional Cooperation** – Indianapolis & the Surrounding Counties

- What we support We support policies and initiatives that provide regional cooperation, resulting in stronger economic development attraction and retention, talent attraction, and smart successful urban growth strategies.
- Why it's important The founding concept of OneZone was Regional Cooperation and as Hamilton County continues to move forward we realize that we should investigate any partnership that has the ability to strengthen the region. OneZone's task is to identify, evaluate and if a potential arrangements will have a positive impact, move it forward.

The OneZone State Advocacy Committee is comprised of varied chamber members that meet on a monthly basis. They identify key issues, research the topics and help define policy positions, which are approved by OneZone's board of directors.
