Exhibitor Guidelines

Setup & Teardown

- Exhibitor check-in and setup begin at 10:30 a.m.
- Check in at exhibitor registration area to receive your table location prior to unloading your materials. Once you unload, you can park and take the complimentary shuttle to and from the parking lot.
- Setup must be completed by 4:15 p.m. for guests arriving at 4:30 p.m.
- Back and side doors will be marked for this event. Use these doors to bring in all materials for your table. Front doors may not be used to transport items.
- Additional representatives, not included in your complimentary tickets, may purchase tickets for \$5 at the registration area.
- Teardown begins at 7:00 p.m. Do not dismantle your display before this time.

Table Regulations

- A 6' or 8' skirted table and 2 chairs will be provided. Displays may not exceed designated area.
- No signage or materials may be affixed to the walls.
- Electricity is available for a \$25 fee. Arrangements and payment must be made in advance. Exhibitors with a reserved electricity location must bring extension cords and power strips
- Wireless Internet service is available at no charge to those with compatible electronic devices. The electricity fee (\$25) will apply if an outlet is needed for the device, and arrangements and payment for electricity must be made in advance.
- **Exhibitors are encouraged to offer something to draw visitors to your booth: food samples, a door prize or giveaways.** These offerings may result in a higher amount of traffic at your table. Exhibitors are responsible for facilitating their own prize drawings, so bring your own fishbowl or similar container to collect business cards or entry forms, along with blank entry forms and pens/pencils. All drawings will take place at 7:15 p.m. Exhibitors will receive further instructions on prize drawing upon check-in at the event.

Food/Beverage Exhibitors - in addition to above guidelines:

- Cooking must stay self-sufficient to exhibitor's table. Exhibitors must provide all cooking and storage equipment/utensils/plates/napkins/glasses, etc. for sampling food or beverages.
- The Ritz Charles kitchen will not be accessible to exhibitors.

**Ritz Charles will have a cash bar available, but please feel free to bring water for your staff.*
